## DEFINITION OF MEMBERSHIP CATEGORIES AVAILABLE TO APPLICANTS

### **A - FULL MEMBER**

Members over 18 years on the 1<sup>st</sup> January in the year of admittance who are entitled to unrestricted play, access to all Club facilities and voting rights at General Meetings.

### **B - INTERMEDIATE MEMBER (18 TO 21 YEARS OF AGE)**

Full Members who are 18 or under 22 years on the 1st January in the year of admittance.

### **C - INTERMEDIATE MEMBER (22 TO 25 YEARS OF AGE)**

Full Members who are 22 or under 26 years on the 1st January in the year of admittance.

### **D – STUDENT MEMBER (18 TO 25 YEARS OF AGE)**

Full Members who are 18 or under 26 years on the 1st January in the year of admittance who are in full time education.

### **E - JUNIOR MEMBER (9 TO 15 YEARS OF AGE)**

Boys and Girls who are 9 or under 16 years on the 1st January in the year of admittance. The minimum age for playing is 9 years unless admitted via the Junior Academy.

### **F - JUNIOR MEMBER (16 TO 17 YEARS OF AGE)**

Boys and Girls who are 16 or under 18 years on the 1st January in the year of admittance.

### **G - COUNTRY 100 MEMBER**

Persons whose home residence is a minimum of 100 miles from the club.

### **H - SOCIAL MEMBER**

A non-playing category which entitles members to use the clubhouse only.

## ADVISORY NOTES

1. The Proposer and Seconder must have been a Full member of Oswestry Golf Club for a **minimum of 2 years**, be personally acquainted with the applicant and accept responsibility for his/her eligibility. Where specified the Proposer is responsible for ensuring that written documentation is attached in support of the applicant's claims.
2. The Proposer is responsible to introduce the applicant to the Executive Committee at the New Members Meeting held prior to or soon after election.
3. Applicants who cannot obtain existing member support for their candidacy may provide a brief written CV verified by the signatures of two references together with their printed names, addresses and telephone numbers. Such applicants may be required to meet a representative of the Club Committee prior to their application being accepted.
4. In the case of application for Full or Intermediate membership a **deposit of £25 must accompany this form**. The deposit will be deducted from the entrance fee at time of joining. The deposit is not returnable if membership is turned down when offered or, if applicant resigns from the waiting list.
5. The Executive Committee may alter the admission policy at any time without notice. The Club reserves the right to remove applicants from the waiting list without explanation.
6. Country members moving to the area and wishing to become Full members may only do so via the waiting list.
7. Those without playing experience are expected to take a course of lessons from the Professional after acceptance as a member and before playing on the course.
